In March 2022, Helbiz was selected as a new vendor for Miami-Dade County's micro-mobility MDS pilot program and was the first to launch its e-scooters in the Greater Dadeland area. Following the success of the first phase of the pilot program, the County has decided to expand its operating area and fleet options in an effort to further analyze the impact of micro-mobility as a first and last mile resource.

"Since our launch in Miami-Dade County, we have seen that Helbiz vehicles have the effect of increasing the range of walking journeys, replacing what would have been a car trip into a multimodal trip assisted by our vehicles and the County's transit system," said Salvatore Palella, Helbiz CEO. "We are thrilled to expand our fleet and operating area, giving more Miami riders access to a sustainable and affordable way to get where they need to go."

Helbiz is the only micro-mobility vendor currently operating in the City of Miami
